

I happen to like Professor Epstein and I think he's one of the best Contracts scholars in America. Yet I have a concern to share. On Professor Epstein's Barbri Contracts lecture handout (at page 80), he energetically advertises his son's restaurant in Charlottesville, VA. It strikes me as ethically inappropriate for a lecturer to advertise a family member's business to a national audience under

the Barbri banner. I brought this to the attention of Barbri's corporate headquarters office and they seemed to pass the buck and not be inclined to do anything (apathy). Perhaps I'm wrong to be concerned. Yet it seems to me that students should not have to pay thousands of dollars for a Barbri course and then be subjected to a Professor providing free advertising for his son.
